This application issues an item from inventory to an account.

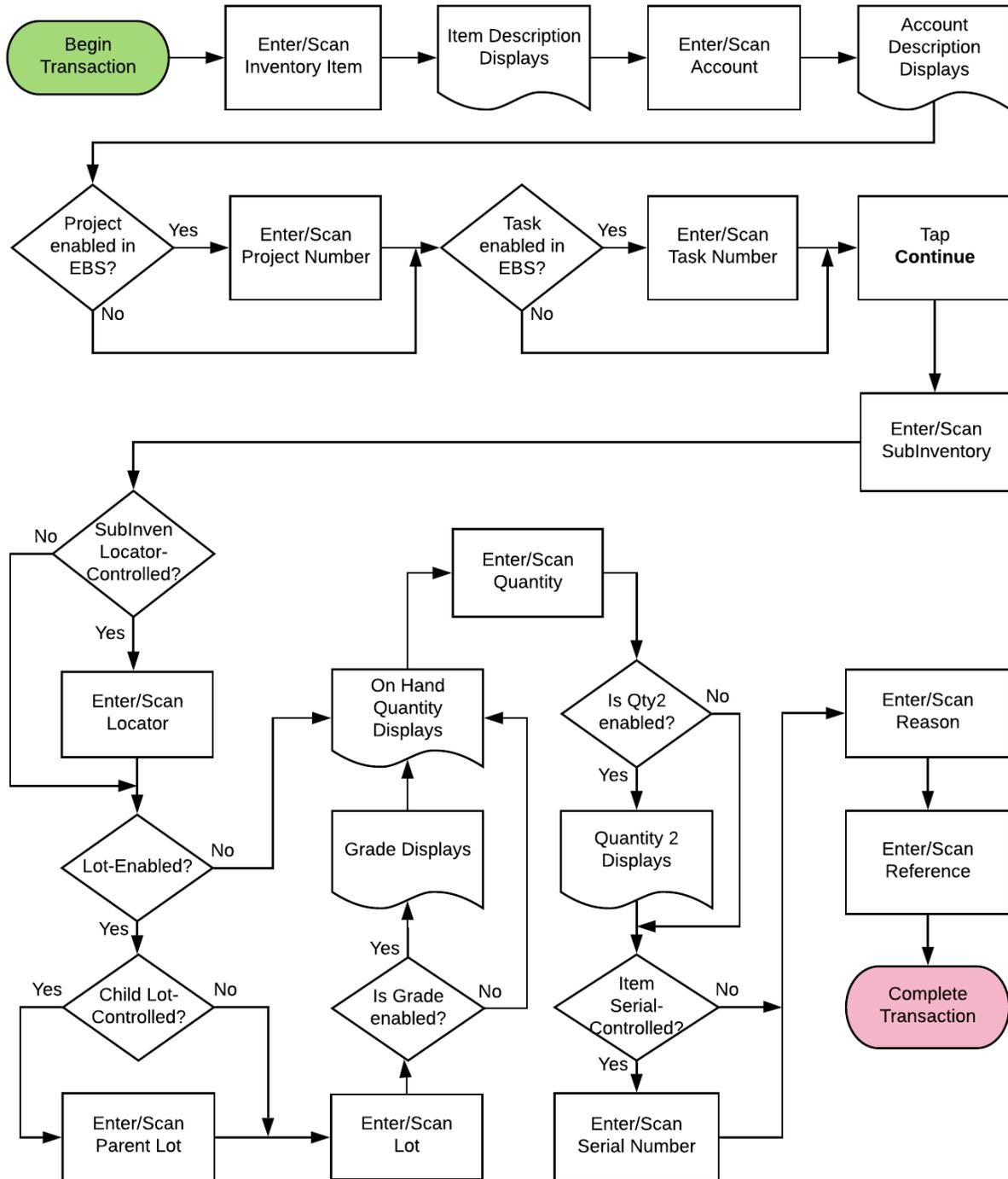

In this document is a description of the application workflow details, technical information, and workflow analysis questions for planning customizations to this application.

This application issues an item from inventory to an Account.



Workflow Details (1 of 2)

The user scans, enters, or searches the inventory item.

The description of the item displays.

If the item is revision-controlled, the user will enter, scan, or, search and select the revision.

Next the user scans, enters, or searches for the account.

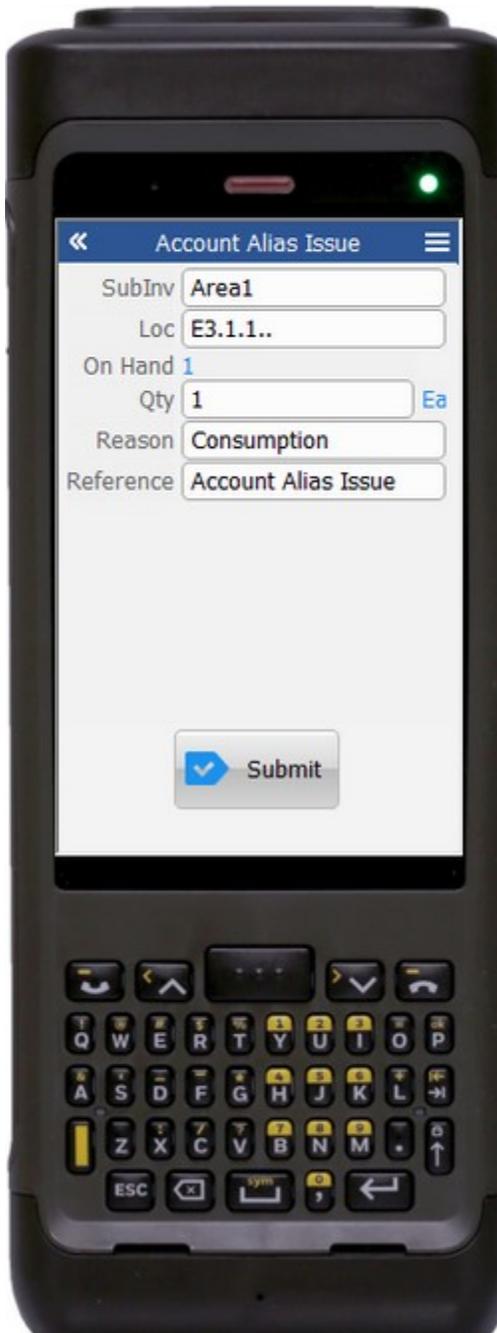
The account description displays.

If the inventory org is project-enabled, the user will enter, scan, or search and select the project and task.

The user taps the **Continue** button which takes the user to Page 2.

The arrow in the top left corner takes the user back to the menu.





Workflow Details (2 of 2)

On page 2, the user enters more Account Alias Issue Transaction details.

The user scans, enters, or searches for the subinventory in SubInv field.

If the subinventory is locator-enabled, then the Locator field displays.

The user scans, enters, or searches the locator (Loc).

If the item is child-lot enabled, the user scans, enters, or searches the parent lot.

If the item is lot-enabled the user will enter, scan, or search and select the lot.

If the item is lot-enabled and, if the lot is grade-enabled, the lot grade displays on the screen.

If enabled, the On Hand quantity displays for the selected item in the organization / Subinventory / Locator / Lot.

The user enters the quantity (Qty). Its unit of measure (UOM) displays.

If the item has a secondary UOM-enabled, the user scans, enters, or searches the Qty2 field. Its UOM will display.

If the item is serial-controlled, the user scans, enters, or searches for the available serials. A running counter for the serials will display.

Next, the user scans, enters, or searches the Reason.

Lastly, the user scans, enters, or searches the application reference in the Reference field.

The **Submit** Button sends the transaction to EBS.

The arrows in the top left corner takes the user back to page 1.
